



It has been a productive year for the Catholic Foundation of Utah, and I am delighted to report the state of the Foundation remains strong. Dedicated work in partnership with our investment advisors, the CFU Investment Committee, and the full CFU Board ensures due diligence is a top priority and that investments always align with USCCB guidelines* and Catholic values.

I continue to be impressed by the level of generosity that flows through the Foundation. Donors are the key to lifting entities throughout our diocese so they can continue to thrive. This fiscal year resulted in strong investment earnings for the Foundation portfolio, allowing nearly \$1 million in distributions to beneficiaries.

Recently, I was honored to lead a Diocesan team in presentations for the Bishop's Finance Road Tour. Designed to offer insight into the financial workings of the Diocese, we presented to the northern, Salt Lake, and southern deanery areas and enjoyed meeting members of multiple parish and finance councils from around the state. The CFU Executive Director, the Director of the Office of Stewardship and Development, and the Diocesan Director of Archives and Records joined me in these presentations. It was an exciting opportunity to connect with parishioners and share the nuts and bolts of our diocesan organization.

The Catholic Foundation of Utah operates as a separate 501 (c) (3) organization under the auspices of the Diocese of Salt Lake City. To that end, the Foundation's consultative board provides vital insight to the Bishop, who in turn relies on their diligence to shepherd the funds entrusted to our care. As you look through the details in this report, you will see that the Foundation has continued steady growth year over year and a protracted five-year view as well. The corpus grew by 1.56% over last year, and endowments increased by 11.9% year over year. Distributions totaled \$958,419.00.

Serving the Catholic Foundation of Utah and its mission continues to be my honor. Thank you for giving. We bear witness to the benefits of your gifts today, as will the generations of tomorrow.






Lifting the Faithful and Sustaining our Faith

The Catholic Foundation of Utah was established to strengthen the Catholic Church in Utah and serve its present and future needs by promoting permanent endowed funds.

Over 200 years ago, the first Catholic priests traveled from New Mexico through Utah, looking for an overland route to the Pacific Ocean. Today, Catholics in Utah number well over 300,000 (10% of the state population) and are served by over 41 priests in 81 parishes, missions, stations, and 16 Catholic schools. The Diocese of Salt Lake City comprises an area of nearly 85,000 square miles.

As the Diocese has grown, so too has the Catholic Foundation of Utah. Since its establishment in 1984, each Bishop has prioritized the Foundation's mission and nurtured asset growth to provide for future generations.




Bishop William K. Weigand, Founder (1980 – 1993)

The Four Pilliars



An endowment was created to support each of the four key pillars of the Catholic Diocese of Utah, by the Board of the Catholic Foundation under former Bishop John C. Wester. Thank you for considering support for one of these endowments (or others) that speak to the ongoing needs within our Diocese.

Pilliar One | EXPANSION OF FACILITIES AND PROGRAMS

The Bishop's Future Fund was created to provide for land purchases for future parishes and missions, new schools, facilities, and expansion and renovation of existing structures.

Pilliar Two | FUNDING CATHOLIC SCHOOLS AND YOUTH MINISTRY

The Youth Ministry and Education Endowment was created to provide funds for catechetical materials and religious education and to bridge the rising costs of education and the need to provide just salaries for educators.

Pilliar Three | TRAINING FOR THE PRIESTHOOD

The Seminarian and Priestly Formation Endowment was created to provide funds to offset the cost of preparation for the priesthood. The lengthy process of academic study, spiritual life formation, and pastoral skills training costs in excess of \$56K annually for each seminarian. A well-funded endowment aids the Diocesan Vocations Office in its recruitment efforts and ensures those who answer the call will be well-educated and trained throughout their lifetime of church service.

Pilliar Four | SUPPORTING RURAL CHURCH COMMUNITIES

The Rural Church Development and Missionary Outreach Endowment was created to provide funds for transportation, including vehicle purchases, technology, and catechetical resource materials. Utah's isolated areas present financial challenges for priests, deacons, and lay people who travel thousands of miles monthly to provide mass, sacraments, and religious education.

Profiles in Generosity

SUPPORTING THE CARMELITE MONASTERY Francis and Joan Hanson | Salt Lake City, Utah



Francis and Joan Hanson are understated on the topic of their altruism. They joyfully support various organizations, but prefer not to trumpet their giving—a testament to how they live their Catholic faith. There are times, however, when the whispers of generosity warrant amplification. Such was the case when the Hansons contemplated the needs of the Carmelites in Holladay, Utah.

Francis, a Professor Emeritus of Chemical Engineering at the University of Utah, and a Notre Dame graduate, attributes his spiritual and pragmatic outlook in part to his friendship with the late Fr. Ted Hesburgh. Fr. Ted, a Catholic priest who served as President of the University of Notre Dame for

35 years, made an indelible impression on Francis and Joan. They fondly recall favorite Fr. Ted quotes that bolstered their desire to live faith by example. Their example is rooted in sharing their gifts—of love, faith, and the fruits of life's labors.

The Hansons recognize that an endowment must be nurtured. It is their hope that others will help support their effort. As Francis stated, he can hear Fr. Ted whispering in his ear..."If it's right, do it."

Francis and Joan established an endowment to benefit the Carmelite Monastery, to provide for its preservation, and to support the needs of the sequestered nuns who serve there. Citing the impact of the pandemic and the modest Carmelite fundraising, the Hansons wanted to do something to ensure future support. "Maybe they can work their way through the next time something happens," Francis said.



The Carmel of the Immaculate Heart of Mary Monastery was founded in 1952 when a group of Carmelite Sisters left the monastery of Carmel of Saint Teresa in Alhambra, California, and arrived in Salt Lake City to establish the Carmelite life and Apostolate in Utah.

The Carmelite Monastery in Salt Lake City is described as follows:



ST. MARTHA'S BABY BASKET Cindy Davidson | Cedar City, Utah

Cindy Davidson is passionate about mothers and babies. Her closets are filled to the rafters with layettes and lotions, blankets and bottles, diapers, and daily necessities, all to give moms and newborns a good start in life.

Cindy believes every mother deserves to feel special following the birth of a child, and every newborn should go home with a new blanket and layette. However, not all moms have the means or support system to provide these things. Imagine giving birth in the hospital while worrying about limited resources. Then imagine a smiling nurse strolling into your room, bearing a beautiful basket full of gifts for you and your baby. That moment of joy is what keeps Cindy busy week after week, year after year, managing St. Martha's Baby Basket Project in Cedar City, Utah. This past year, they distributed 53 baskets— 29 baskets for baby boys and 24 for baby girls. A grand total of 1,060 have been gifted over 29 years.

Cindy and her small army of volunteers work tirelessly gathering, purchasing, and categorizing the items they stock for the baskets. There are seasonal layettes for babies born on holidays, boy and girl



outfits, and gift cards for moms. Every quilt is sewn lovingly by hand. Cindy is grateful for the storage space provided by her parish, Christ the King Catholic Church.

Donations help fund this effort, but Cindy recognized it would take more to support St. Martha's Baby Basket Project long-term. So, she started to save. She contacted the Catholic Foundation of Utah about establishing an endowment. Then she saved some more. Eventually, Cindy was able to establish an endowment, which now provides an annual distribution to help cover expenses.

The need is ongoing, and the gratitude is palpable. Cindy recalls checking out at Walmart one day, her cart filled with newborn-sized clothing and necessities. The cashier asked if she had multiple grandchildren of the same age. Cindy laughed and explained the charitable effort, at which point the female cashier's face stretched into a smile. "I received one of your baskets!" she said. It was a rare and gratifying connection that Cindy will never forget. The women exchanged hugs, and Cindy left, knowing that the impact on that young mom would endure, just as the endowment purpose intends.

REFLECTIONS ON MY SPIRITUAL JOURNEY By Fr. Oscar Marquina

I had always felt God's providential care through prosperity and worldly success. In fact, it was one of the reasons I reverted back to the Catholic faith— I wanted to start going to Church in thanksgiving for all of God's blessings in my life. In my mind, God's presence was demonstrated when everything was going well. I received scholarships, job promotions, and travel opportunities, which allowed me to store worldly treasures on earth. My spiritual life, ironically enough, was praying for material treasures and seeing God's hand in the gifts received. When I received moments of intelligence, periods of good health, and bonuses from promotions, I would think, 'This is great, such great luck!' But what is the true Christian perspective? What is the right thing to ask for to grow spiritually?

Spending time with Christ in the Eucharist, listening to the readings at Mass, and taking time in silence to reflect, I began understanding that things can work for good or for evil. After years of praising God for incredible providential moments in my life, I began to see that these blessings, while seemingly positive, could also impede my personal and spiritual growth. Ultimately, money can be used by an honest man or by a criminal. Money can rescue the lives of people who are suffering or can isolate individuals and communities. Health can be used to give oneself over to the family and community, but having good health can also be an occasion for all kinds of abuses, and so on with many other things, above all intelligence. The decisive thing in life is not in what comes to me but in how I respond to what comes my way.

It's taken a long time to go from finding joy in providential gifts and being "lucky" to growing more selfaware in order to use my conscience, knowledge, character, and conviction of heart to respond to life's gifts and events. This spiritual maturity has happened with time, but most importantly, it happened alongside the constant presence of Christ in the sacraments. Christ has given me the conviction that there are other types of treasures to accumulate!

The Bible teaches that we should not hastily label events as good or bad but rather focus on our responses to them. It all depends on how you use it and what you do with what life has given you. There are people who have suffered a lot and have made their suffering a path of mercy, solidarity, and a great testimony for us all. God uses events, sometimes good, sometimes bad, to show His justice and His providence. Rather than thinking of all the possible "what if" scenarios, it's best to reflect on how I could respond with virtue, love, and trust in God's presence. Greater than the stories and experiences of God's providential events is the self-knowledge that comes from each of them. These moments of great providence have now become an insight into my priorities, strengths, weaknesses, and dependency on Christ. The Christian life has many dimensions, and this is just one thread of my spirituality.

As I write this, I'm just now noticing that I am halfway through my time in the seminary. I have been in seminary for three complete years and have two-and-a-half more to go before I become a priest. When I look back on my life, I am still surprised that I'm even here at all— but I am very thankful, and I look forward to serving the Church as one of her priests. Though I am a seminarian for the Catholic Diocese of Utah— I was neither raised Catholic, nor in Utah. In fact, I was baptized as an Episcopalian and raised as a Lutheran in North Carolina.

I had a pretty average upbringing: I played baseball and trombone, participated in church and other social functions. After high school, I went to college and graduated with a BA in English. I became a TV journalist for a local news station in North Carolina. I was a producer and worked entirely behind the camera. In 2015, after working in news for over three years, I was looking for a change of scenery and started to work at Fox13 in Salt Lake City. Immediately, I fell in love with Salt Lake and Utah. It had everything I wanted: backpacking, skiing, snowshoeing, film festivals – all the adventures a man in his mid-twenties could want.

However, things took a turn in 2017. I was going through a bit of a hard time and was looking for a deeper fulfillment in life. I tried hiking, backpacking, and all the adventures, but they weren't doing it for me anymore. One day, I was walking around downtown Salt Lake City when I noticed the Cathedral of the Madeleine. I had never been inside before, so I thought I'd take a look. I walked in and was admiring the beautiful art and architecture when I decided to kneel down and pray. What happened next changed my life forever. As I was praying, I started to realize all the ways I pushed Christ to the peripheries of my life, and He showed me how making Him central in my life would bring me the fulfillment I was looking for. I felt His closeness in a way I had never felt before, and I truly believe it was my soul recognizing the real presence of Christ in the Eucharist. I walked into the cathedral as a Protestant, and I walked out as a Catholic.

Immediately, I joined RCIA and was received into the Church on the Easter Vigil of 2018. Throughout my twenties, I had always felt a tug toward life as a minister but could never pull the trigger on the idea. When I became Catholic, that reluctance disappeared, and I realized I was simply looking for a church where I could see myself as a priest, and that is what Catholicism offers me. Now, I study in Rome. My time in seminary has brought me closer and closer to Christ, and I realize that conforming yourself to Christ is life's truest adventure. It's the adventure God wants us all to take part in, and I can't wait to share my adventure with the people of Utah and encourage them on their own journeys.


